WHEREAS, the City Planning Commission filed with the Council on January 3, 2002 its decision dated December 19, 2002 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of one (1) city-owned property pursuant to zoning, located at 480-500 Van Brunt Street (Block 611/Lots 6 and 11), Borough of Brooklyn (ULURP No. C 020048 PPK) (the "Application");

WHEREAS, the Application is related to ULURP Applications C 020046 ZRK (L.U. No. 63), an amendment to the text of the Zoning Resolution; C 020047 ZMK (L.U. No. 62), an amendment to the Zoning Map; and C 020049 ZSK (L.U. No. 65), a special permit pursuant to Section 74-922;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(3) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on January 25, 2002;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application; and

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration, issued on August 9, 2001 (CEQR No. 00DME013);
