State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senators Maltese, Padavan, Velella, Marchi, Spano, Leibell, Skelos, Balboni, Fuschillo, Hannon, Johnson, Lack, Lavalley, Marcellino, Trunzo and Morahan, S.5852-B, and Assembly Member Abbate, A.10373-A, "AN ACT to amend the administrative code of the city of New York, in relation to increasing benefits payable by the police and fire variable supplements funds to pension fund beneficiaries".

Whereas, bills have been introduced in the New York State Legislature by Senators Maltese, Padavan, Velella, Marchi, Spano, Leibell, Skelos, Balboni, Fuschillo, Hannon, Johnson, Lack, Lavalley, Marcellino, Trunzo and Morahan, S.5852-B, and Assembly Member Abbate, A.10373-A, "AN ACT to amend the administrative code of the city of New York, in relation to increasing benefits payable by the police and fire variable supplements funds to pension fund beneficiaries"; and
