Whereas, bills have been introduced in the New York State Legislature by" Senators Maltese, Balboni, Hannon, Johnson, Lavallo, Leibell, Marcellino, Marchi, Morahan, Padavan, Spano, Trunzo and Velella, S.6473-A, and Assembly Member Abbate, A.10407-A, "AN ACT to amend the retirement and social security law and the administrative code of the city of New York, in relation to the final average salary of members of the New York city police pension fund and fire department pension fund who are subject to the provisions of article eleven of the retirement and social security law"; and
