No. 95; C 020246 HAM).

WHEREAS, the City Planning Commission filed with the Council on April 23, 2002 its decision dated April 17, 2002 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 267 West 118th Street; 161, 163 and 165 St. Nicholas Avenue (Block 1924/Lots 11, 13, 14 and 15, as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of 163 St. Nicholas Avenue (Block 1924/Lot 14) to a developer selected by the Department of Housing Preservation and Development to facilitate construction of a 6-8 story building, tentatively known as Rosa Parks Gardens, with approximately 64 units of housing and community facility space, Community District 10, Borough of Manhattan (the "Disposition") (ULURP No. C 020246 HAM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its recommendations regarding the Application on April 4, 2002;

WHEREAS, upon due notice, the Council held a public hearing on the Application and Decision on May 14, 2002;

WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Application;

RESOLVED:

The Council finds that the actions described herein will have no significant effect on the environment;

Pursuant to Section 197-d, the Council approves the decision of the City Planning Commission (C 020220 HAM).

The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council approves the designation of the Disposition Area as an urban development action area pursuant to Section 693 of the General Municipal Law.

The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.
