WHEREAS, the City Planning Commission filed with the Council on June 17, 2002 its decision dated June 12, 2002 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, Division of Real Estate Services for the disposition of three (3) city-owned residential properties pursuant to zoning, located at Washington Avenue (Block 2371/Lot 22), 500-502 East 167th Street (Block 2371/Lot 33), and 973 Washington Avenue (Block 2385/Lot 44), Community District 3, Borough of the Bronx (ULURP No. C 020271 DMX) (the "Application");
