WHEREAS, the City Planning Commission filed with the Council on June 17, 2002 its decision dated June 12, 2002 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of two (2) city-owned properties pursuant to zoning, located at 1605 Mermaid Avenue (Block 7021/Lot44) and 2929 West 19th Street (Block 7061/Lot 39), Community District 13, Borough of Brooklyn (ULURP No. C 020176 PPK) (the "Application");
