WHEREAS, the City Planning Commission filed with the Council on August 14, 2002 its decision dated August 7, 2002 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 228, 230/232 East 3rd Street (Block 385/Lots 19 and 20) and 307, 305, 303, 301, 299 East 3rd Street (Block 373/Lots 51 and 53-56), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by the Department of Housing Preservation and Development to facilitate construction of a seven-story building, tentatively known as Carol L. Watson Houses and a six- story building tentatively known as Bitman Rivas Houses with 60 units of housing for low-income families and community facility space (the "Disposition") (ULURP No. C 020469 HAM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

| The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law |
