Resolution affirming the designation by the Landmarks Preservation Commission of the 49 West 28<sup>th</sup> Street Building, Tin Pan Alley located at 49 West 28<sup>th</sup> Street (Tax Map Block 830, Lot 10), Borough of Manhattan, Designation List No. 516, LP-2627 (L.U. No. 619; 20195576 HIM; N 200224 HIM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on December 19, 2019 a copy of its designation report dated December 10, 2019 (the "Designation"), designating the 49 West 28<sup>th</sup> Street Building, Tin Pan Alley located at 49 West 28<sup>th</sup> Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 830, Lot 10, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the New York City Charter and Section 25-303 of the Administrative Code of the City of New York;

WHEREAS, the City Planning Commission submitted to the Council on February 7, 2020, its report on the Designation dated February 5, 2020 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on February 12, 2020; and
WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation.
