WHEREAS, the City Planning Commission filed with the Council on September 26, 2002 its decision dated September 18, 2002 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Cultural Affairs for site selection of property located on the west side of Buffalo Avenue between Bergen Street and St. Marks Avenue, Site 2b within the Crown Heights Urban Renewal Area (Block 1356/Lots 30-35, 37-51, 53, and 54), and on the northeast corner of Buffalo and St. Marks Avenues, Site 2d within the Crown Heights Urban Renewal Area (Block 1357/Lots 1-3), Community District 8, Borough of Brooklyn (the "Site"), for use as a museum and accessory parking (ULURP No. C 020632 PSK) (the "Application");
