WHEREAS, the City Planning Commission filed with the Council on October 22, 2002 its decision dated October 16, 2002 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 61 and 63 Lenox Avenue (Block 1823/Lots 29 and 30), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by the Department of Housing Preservation and Development to facilitate reconstruction of an existing building and construction of a new five-story building with a total of 15 units of housing with ground floor commercial space under HPD's Vacant Buildings 2000 Program, Community District 10, Borough of Manhattan (the "Disposition") (ULURP No. C 020674 HAM) (the "Application");
