WHEREAS, the Landmarks Preservation Commission filed with the Council on December 26, 2002 a copy of its designation dated December 17, 2002 (the "Designation"), of the 121 Heberton Avenue House, located at 121 Heberton Avenue, Community District 1, Borough of Staten Island as a landmark and Block 1015/Lot 9 as its landmark site, pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on February 12, 2003 its report on the Designation dated February 5, 2003 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on March 4, 2003; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
