State Legislation Resolution requesting the New York State Legislature to pass bills, introduced by Senators Maltese, Padavan and Velella, S.2221, and Assembly Members Abbate, Cymbrowitz, Ortiz, Pheffer, Rivera, Seddio and Weisenberg, et al, A.4828, "AN ACT to amend the administrative code of New York, in relation to the crediting of certain prior service by the police pension fund of such city".

Whereas, bills have been introduced in the New York State Legislature by Senators Maltese, Padavan and Velella, S.2221, and Assembly Members Abbate, Cymbrowitz, Ortiz, Pheffer, Rivera, Seddio and Weisenberg, et al, A.4828, "AN ACT to amend the administrative code of New York, in relation to the crediting of certain prior service by the police pension fund of such city"; and

Whereas, The enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it

Resolved, That the Council of the City of New York, in accordance with the provisions of Section 2 of Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bills.
