WHEREAS, the City Planning Commission filed with the Council on February 26, 2003 its decision dated February 19, 2003 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of four (4) city-owned properties pursuant to zoning, located at 735 Dean Street (Block 1130/Lot 53), 1777 Pacific Street (Block 1336/Lot 63), 65 Utica Avenue (Block 1337/Lot 4), and 63 A Utica Avenue (Block 1337/Lot 5), Community District 8, Borough of Brooklyn (ULURP No. C 030027 PPK) (the "Application");
