Resolution approving a motion to file pursuant to withdrawal of an application submitted by the Department of Housing Preservation and Development, ULURP No. C 030245 HAM (L.U. No. 361).

WHEREAS, the City Planning Commission filed with the Council on April 28, 2003 its decision dated April 23, 2003 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

a) the designation of 65, 63, 61, 59, and 31/35 W. 115th Street and 24, 26, 28, 30, 32, 34, 36/40, 42, 46 and 48 W. 116th Street (Block 1599, Lots 13-15, 17, 18, 47-53, 56, 58 and 59, as an Urban Development Action Area (the "Area");

b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer selected by the Department of Housing Preservation and Development (the "Disposition") (ULURP No. C 030245 HAM) (the "Application");

WHEREAS, the Application is related to ULURP Applications Numbers C 030243 HUM (L.U. No. 359), an urban renewal plan amendment, and C 030244 ZMM (L.U. No. 360), an amendment to the Zoning Map;

WHEREAS, by letter dated May 29, 2003, the Department of Housing Preservation and Development withdrew the application;

WHEREAS, upon due notice, the Council held the public hearing on May 29, 2003;

RESOLVED:

Pursuant to Section 2-02(5)(d) of the Rules of the City of New York and Rule 6.40 of the Council of the City of New York the Council approves the motion to file pursuant to withdrawal.
