WHEREAS, the Landmarks Preservation Commission filed with the Council on April 3, 2003 a copy of its designation dated March 25, 2003 (the "Designation"), of the Brown Building (originally the Asch Building) located at 23-29 Washington Place (aka 245 Greene Street), Community District 2, Borough of Manhattan, as a landmark and Block 547, Lot 8, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on May 28, 2003, its report on the Designation dated May 21, 2003 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on June 17, 2003; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
