WHEREAS, the City Planning Commission filed with the Council on May 12, 2003 its decision dated May 7, 2003 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Citywide Administrative Services, for the disposition of one (1) city-owned property pursuant to zoning, located at 72 Poplar Street (Block 211/Lot 15), Community District 2, Borough of Brooklyn (ULURP No. C 030175 PPK) (the "Application");

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on June 17, 2003; and
