Resolution approving the decision of the City Planning Commission on Application No. N 030334 ZRX, an amendment to the text of the Zoning Resolution regarding Article XII, Chapter 3 (Special Mixed Use District) specifying a Special Mixed Use District (MX-7) in Morrisania, the Bronx (L.U. No. 476).

WHEREAS, the City Planning Commission filed with the Council on July 30, 2003 its decision dated July 23, 2003 (the "Decision"), on the application submitted by the Department of City Planning, pursuant to Section 201 of the New York City Charter, for an amendment to the text of the Zoning Resolution (Application No. N 030334 ZRX) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 030333 ZMX (L.U. No. 475), an amendment of the Zoning Map;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on August 18, 2003;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application; and

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration, issued on March 3, 2003, which includes (E) designation (E-118) for hazardous materials on various blocks (CEQR No. 03DCP046X);

RESOLVED:
