WHEREAS, the City Planning Commission filed with the Council on July 30, 2003 its decision dated July 23, 2003 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 459 West 140th Street (Block 2057/Lot 36), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer selected by the Department of Housing Preservation and Development to facilitate the rehabilitation of an existing building for use as a community facility (the "Disposition"), Community District 9, Borough of Manhattan (ULURP No. C 030316 HAM) (the "Application");

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;

WHEREAS, upon due notice, the Council held a public hearing on the Application and Decision on August 18, 2003;				
WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Application;				
RESOLVED:				
Pursuant to Section 197-d, the Council approves the decision of the City Planning Commission (C 030316 HAM).				
The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.				
The Council approves the designation of the Disposition Area as an urban development action area pursuant to Section 693 of the General Municipal Law.				
The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law				
The Council approves the disposition of said property to a developer selected by the Department of Housing Preservation.
