WHEREAS, the City Planning Commission filed with the Council on August 29, 2003 its decision dated August 27, 2003 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- the designation of 884, 886, 888, and 890 Southern Boulevard, a part of Site 314 within the Longwood Urban Renewal Area (Block 2733/Lots 11-14), as an Urban Development Action Area (the "Area");
- an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer selected by the Department of Housing Preservation and Development to facilitate the construction of a community playground, Community District 2, Borough of the Bronx (the "Disposition") (ULURP No. C 030438 HAX) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 030437 HAX (L.U. No. 487), an urban development action area project;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;					
WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its recommendations regarding the Application on August 12, 2003;					
WHEREAS, upon due notice, the Council held a public hearing on the Application and Decision on September 15, 2003;					
WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Application;					
RESOLVED:					
Pursuant to Section 197-d, the Council approves the decision of the City Planning Commission (C 030438 HAX).					
The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.					
The Council approves the designation of the Disposition Area as an urban development action area pursuant to Section 693 of the General Municipal Law.					
The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.					
The Council approves the disposition of said property to a developer selected by the Department of Housing Preservation and Development.
