THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1175

Resolution approving an Urban Development Action Area Project located at 2928 West 36th Street (Block 7045/part of Lot 1), Brooklyn, and approving the urban development action area designation, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 516; 20045123 HAK).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on August 12, 2003 its request dated July 28, 2003 that the Council take the following actions regarding an Urban Development Action Area Project (the "Project") located at 2928 West 36th Street (Block 7045/part of Lot 1), Borough of Brooklyn (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes of Section 691 of the General Municipal Law;
- 2. Approve the designation of the Disposition Area as an Urban Development Action Area pursuant to Section 693 of the General Municipal Law; and
- 3. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law.

WHEREAS, the Application is related to ULURP Applications Numbers C 010351 HUK (L.U. No. 135, Res. No. 412 of 2002), C 010352 HAK (L.U. No. 136, Res. No. 413 of 2002), C 010353 ZSK (L.U. No. 137, Res. No. 414 of 2002) and C 010354 HAK (L.U. No. 138, Res. No. 415 of 2002);

WHEREAS, the Project is to be developed on land that is now a municipally-owned area as defined in Section 692 of the General Municipal Law, consists solely of the rehabilitation or conservation of existing private or multiple dwellings or the construction of one to four unit dwellings, and does not require any change in land use permitted under the New York City Zoning Resolution;

WHEREAS, upon due notice, the Council held a public hearing on the Project on November 17, 2003;

WHEREAS, the Council has considered the land use implications, the environmental and other policy issues relating to the Project;

## RESOLVED:

The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council approves the area designation requirement of the Disposition Area as an urban development action area under Section 693 of the General Municipal Law pursuant to said Section.

The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.

The Project shall be disposed of and developed upon the terms and conditions in the Project Summary that HPD has submitted to the Council, a copy of which is attached hereto.
