Resolution approving an amendment to the designation of the Brooklyn Center Urban Renewal Area (N 040176 HGK; L.U. No. 156).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to and received by the Council on May 10, 2004 its request pursuant to Section 504 of Article 15 of the General Municipal Law that the Council designate the following properties described in the Brooklyn Center Urban Renewal Plan, dated May 3, 2004, as the Brooklyn Center Urban Renewal Area (the "Area"), Community District 2, Borough of Brooklyn:

WHEREAS, upon due notice, the Council held a public hearing on the designation of the Area on June 8, 2004 and was recessed until June 10, 2004;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Area;

WHEREAS, the Council has considered the relevant environmental issues and the Final Environmental Impact Statement ("FEIS") for which a Notice of Completion was issued on April 30, 2004 which identified significant adverse impacts and proposed mitigation measures (CEQR No. 03DME016K);

RESOLVED:

The Council finds that the Area is appropriate for urban renewal.

Having considered the FEIS, with respect to the Application, the Council finds that:

- (1) The FEIS meets the requirements of 6 N.Y.C.R.R. Part 617;
- (2) From among the reasonable alternatives thereto, the actions to be approved are ones which minimize or avoid adverse environmental impacts to the maximum extent practicable; and
- (2) The adverse environmental impacts revealed in the FEIS will be minimized or avoided to the maximum extent practicable by incorporating as conditions to the approval those mitigative measures that were identified as practicable;
- (2) The Decision and the FEIS constitute the written statement of facts, and of social, economic and other factors and standards that form the basis of this determination, pursuant to 6 N.Y.C.R.R. §617.11(d).

Pursuant to Section 504 of the General Municipal Law, the Council designates the Area as the Brooklyn Center Urban Renewal Area.
