Resolution approving the motion to file pursuant to withdrawal an application submitted by the Department of Housing Preservation and Development, ULURP No. C 040203 HAK (L.U. No. 91; C 040203 HAK).

## By Council Members Katz and Martinez

WHEREAS, the City Planning Commission filed with the Council on June 17, 2004 its decision dated June 9, 2004 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of 433-439 DeWitt Avenue (Block 4318/Lots 31-34), as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of 433, 437, and 439 DeWitt Avenue (Block 4318/Lots 31, 32 and 34) to a developer selected by the Department of Housing Preservation and Development to facilitate the development of a four-story building tentatively known as PSCH DeWitt Residence, with approximately 19 apartments for low-income persons with mental illness, to be developed under the HUD Section 811 Supportive Housing for Persons with Disabilities Program, Community District 5, Borough of Brooklyn (the "Disposition") (ULURP No. C 040203 HAK) (the "Application"); and
