WHEREAS, the New York City Health and Hospitals Corporation, filed with the Council on December 17, 2004 notice of the Board of Directors' authorization dated December 16, 2004 of the leasing agreement between the New York City Health and Hospitals Corporation and a consortium consisting of Sodexho HealthCare Services, Inc., U.S. Foodservice, Inc., and Greater New York Hospital Association Ventures, Inc., of the food service building located on the Kings County Hospital Center campus located at 451 Clarkson Avenue (Block 4812/Lot 1) upon terms and conditions set forth in the Health and Hospitals Corporation resolution authorizing the leasing, a copy of which is attached hereto (the "Leasing"), Community District 9, Borough of Brooklyn;

WHEREAS, the Leasing is subject to review and action by the Council pursuant to Section 7385(6) of the Health and Hospitals Corporation Act;

WHEREAS, upon due notice, the Council held a public hearing on the Leasing on January 12, 2004; and
