## Be it enacted by the Council as follows:

Section One. Section 14-147 of chapter 1 of title 14 of the administrative code of the city of New York

is hereby amended by adding a new subdivision c, to read as follows:

§14-147 Workers' compensation and funeral benefits for members of auxiliary police.

c. Funeral benefits for auxiliary police. The mayor is hereby authorized and empowered to make an

## award for funeral expenses to the survivors of an auxiliary police officer who has been or hereafter shall die,

§2. This local law shall take effect immediately.
