State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senator Krueger S.2735 and Assembly Member Lopez A.4523, "AN ACT to amend the local emergency housing rent control act, in relation to rent regulation law."

**Whereas** bills have been introduced in the New York State Legislature by Senator Krueger S.2735 and Assembly Member Lopez A.4523, "AN ACT to amend the local emergency housing rent control act, in relation to rent regulation law;" and

**Whereas**, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore be it

**Resolved**, that the Council of the City of New York, in accordance with the provisions of Section 2 of the Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bill.
