Whereas, bills have been introduced in the New York State Legislature by Senator Maltese, S.2519, and Assembly Member Abbate, A.7243, "AN ACT to amend the retirement and social security law, in relation to deputy sheriffs members of the New York City employees' retirement system"; and

Whereas, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
