Whereas, bills have been introduced in the New York State Legislature by Senator Padavan, S.3217, and Assembly Member McLaughlin, A.6302, "AN ACT to amend the vehicle and traffic law and the state finance law, in relation to the imposition of a mandatory surcharge on speeding violations committed within a work zone and the creation of a photo radar monitoring enforcement demonstration program"; and
