# Resolution approving the leasing of a parcel of approximately 8 acres of land located on the Jacobi Medical Center campus, the Bronx (20055646 HHX; L.U. No. 511).

## By Council Members Katz and Felder

WHEREAS, the New York City Health and Hospitals Corporation, filed with the Council on June 14, 2005 notice of the Board of Directors authorization dated June 9, 2005 of the leasing agreement to the Albert Einstein College of Medicine of Yeshiva University of an approximately 8 acre parcel of land located on the Jacobi Medical Center campus to be developed for use as student and faculty housing, Community District 11, Borough of the Bronx, upon the terms and conditions set forth in the Health and Hospitals Corporation resolution authorizing the leasing, a copy of which is attached hereto (the "Leasing");

WHEREAS, the Leasing is subject to review and action by the Council pursuant to Section 7385(6) of the Health and Hospitals Corporation Act;

WHEREAS, upon due notice, the Council held a public hearing on the Leasing on July 25, 2005; and

WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Leasing;
