A Local Law to amend the effective date of local law one of the year 2002.

Be it enacted by the Council as follows:

Section 1. Section five of local law one of the year 2002 is amended to read as follows:

§5. Effective date. This local law shall take effect one hundred eighty days after its enactment[;

provided, however, that section three of this local law shall have no further force or effect and shall be deemed repealed on October 1, 2005]. Actions necessary to prepare for the implementation of this local law may be taken prior to its effective date.

§2. This local law shall take effect immediately.
