WHEREAS, the Landmarks Preservation Commission filed with the Council on May 23, 2005, copy of its designation dated May 17, 2005 (the "Designation"), of the Ralph Bunche House located at 115-24 Grosvenor Road, Kew Gardens, Community District 9, Borough of Queens, as a landmark and Block 3319, Lot 18, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on July 19, 2005 its report on the Designation dated July 13, 2005 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on September 7, 2005; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
