Whereas, bills have been introduced in the New York State Legislature by Senator Golden, S.4503-A, and Assembly Member Abbate, A.7393-A, "AN ACT to amend the retirement and social security law, the administrative code of the city of New York and the education law, in relation to the establishment of a twenty-five year retirement program for members of the New York city employees' retirement system or the board of education retirement system of the city of New York employed in construction laborer position"; and
