State Legislation Resolution No. 78

State Legislation Resolution requesting the New York State Legislature to pass bills introduced by Senator Padavan, S.7119-A, and Assembly Member Abbate, A.10530, "AN ACT to amend the retirement and social security law, in relation to accidental disability for certain members of the New York city employees' retirement system or the New York city board of education retirement system".

Whereas, bills have been introduced in the New York State Legislature by Senator Padavan, S.7119-A, and Assembly Member Abbate, A.10530, "AN ACT to amend the retirement and social security law, in relation to accidental disability for certain members of the New York city employees' retirement system or the New York city board of education"; and

Whereas, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it

**Resolved**, that the Council of the City of New York, in accordance with the provisions of Section 2 of Article 9 of the Constitution of the State of New York, does hereby request the New York State Legislature to enact into law the aforesaid pending bills.
