**Whereas**, bills have been introduced in the New York State Legislature by Senator Padavan, S.3974-A, and Assembly Member Abbate, A.7023-A, "AN ACT to amend the administrative code of the city of New York, in relation to establishing a variable supplements fund for sanitation members of the New York city employees' retirement system holding the title of sanitation worker"; and

**Whereas**, the enactment of the above State Legislation requires the concurrence of the Council of the City of New York as the local legislative body; now, therefore, be it
