Whereas, a bill has been introduced in the New York State Legislature by Senator Hassell-Thompson, S.5520-A, "AN ACT authorizing the city of New York to reconvey its interest in certain real property acquired by in rem tax foreclosure in the borough of the Bronx to former owner, Estate of Elia Figueroa without public auction and notwithstanding expiration of the two year period within which application may be made to the city to release its interest in property thus acquired; Block No. 3062, Lot No. 3 on tax map for the borough of the Bronx "; and
