WHEREAS, the Landmarks Preservation Commission filed with the Council on June 30, 2006 a copy of its designation dated June 20, 2006 (the "Designation"), of (Former) Public School 64 (P.S. 64), located at 605 East 9<sup>th</sup> Street (aka 605-615 East 9<sup>th</sup> Street and 350-360 East 10<sup>th</sup> Street), Community District 3, Borough of Manhattan, as a landmark and Block 392, Lot 10, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on August 25, 2006, its report on the Designation dated August 23, 2006 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on September 7, 2006; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
