# THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 619

Resolution approving the decision of the City Planning Commission on ULURP No. C 060465 ZMR, a Zoning Map change (L.U. No. 305).

WHEREAS, the City Planning Commission filed with the Council on October 13, 2006 its decision dated October 11, 2006 (the "Decision"), on the application submitted by the Department of City Planning and Council Member Andrew J. Lanza, pursuant to Sections 197-c and 201 of the New York City Charter, for an amendment to the Zoning Map (ULURP No. C 060465 ZMR) (the "Application");

WHEREAS, the Application is related to Application Number N 060464 ZRR (L.U. No. 306), a zoning text amendment to the Special South Richmond Development District to establish special areas, Area LL (Large Lots) and Area SH (Senior Housing);

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on November 1, 2006;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application; and

WHEREAS, the Council has considered the relevant environmental issues and the Revised Negative

Declaration, issued on October 11, 2006 (CEQR No. 06DCP098R);

### RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment.

Pursuant to Sections 197-d and 200 of the City Charter and on the basis of the Decision and Application, the Council approves the Decision.

The Zoning Resolution of the City of New York, effective as of December 15, 1961, and as subsequently amended, is further amended by changing the Zoning Map, Section Nos. 35a and 35c:

- 1. changing from an R3X District to an R1-2 District property bounded by Hylan Boulevard, Indale Avenue, Johnston Terrace, and Sharrott Avenue; and
- 2. changing from an R3-2 District to an R3X District property bounded by the southwesterly centerline prolongation of Sherwood Avenue, Sharrott Avenue, Hylan Boulevard, and a line 100 feet northeasterly of Richard Avenue;

within the Special South Richmond Development District, as shown on a diagram (for illustrative purposes only) dated May 8, 2006, Community District 3, Borough of Staten Island.
