A Local Law in relation to the temporary task force to study the feasibility of transferring city-owned wetlands to the jurisdiction of the department of parks and recreation.

Be it enacted by the Council as follows:

Section 1. Subdivision c of section two of local law number 37 for the year 2006 is amended to read as follows:

c. Such members of the task force shall serve until [February 17, 2007] December 31, 2007, after which

time such task force shall cease to exist.

§2. This local law shall take effect immediately upon its enactment and shall be deemed to have been in full force and effect as of February 17, 2007.
