Section 1. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

§2. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

Douglas Road	Douglas Road/ Marinette Street	Between Hillside Avenue and West Drive

§3. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

New Name	Present Name	Limits
Little Neck Road	38 <sup>th</sup> Drive	Between Circle Road and Cherry Street

§4. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

New Name	Present Name	Limits
Cherry Street	39 <sup>th</sup> Avenue	Between Douglaston Parkway and Little Neck Road

§5. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

New Name	Present Name	Limits
Willow Street	40 <sup>th</sup> Avenue	Between Douglaston Parkway and Circle Road

§6. The following street name, in the Borough of Queens, is hereby designated as hereafter indicated.

New Name	Present Name	Limits
Boulevard	141 <sup>st</sup> Street	Between the intersection of Center Drive and Point Crescent to the intersection of 141 <sup>st</sup> Street and Boulevard

§7. The official map of the city of New York shall be amended in accordance with the provisions of sections one through six of this local law.

§8. This local law shall take effect immediately.
