Resolution affirming the designation by the Landmarks Preservation Commission of the Church of All Saints (Roman Catholic) Parish House and School located at 47 East 129<sup>th</sup> Street (aka 50-52 East 130<sup>th</sup> Street, 2041-2053 Madison Avenue, and 41-45 East 129<sup>th</sup> Street) (Block 1754, Lots 20 and 24), Manhattan, Designation List No. 385, LP-2165 (Preconsidered L.U. No. 415; 20075239 HKM; N 070329 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on February 9, 2007, a copy of its designation dated January 30, 2007 (the "Designation"), of the Church of All Saints (Roman Catholic) Parish House and School located at 47 East 129<sup>th</sup> Street (aka 50-52 East 130<sup>th</sup> Street, 2041-2053 Madison Avenue, and 41-45 East 129<sup>th</sup> Street), Community District 11, Borough of Manhattan, as a landmark and Block 1754, Lots 20 and 24, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on March 30, 2007 its report on the Designation dated March 28, 2007 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on April 11, 2007; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
