THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 817

Resolution approving the decision of the City Planning Commission on ULURP No. C 010284 MMX, an amendment to the City Map (L.U. No. 400).

WHEREAS, the City Planning Commission filed with the Council on March 5, 2007 its decision dated February 28, 2007 (the "Decision"), on the application submitted by Horace Mann School, pursuant to Sections 197-c and 199 of the New York City Charter and Section 5-430 *et seq*. of the New York City Administrative Code, for an amendment to the City Map involving:

- the elimination, discontinuance and closing of West 250th Street between Tibbett Avenue and The Post Road;
- the adjustment of grades necessitated thereby; and
- any acquisition or disposition of real property related thereto,

in accordance with Map No. 13097, dated September 3, 2002 and signed by the Borough President (ULURP No. C 010284 MMX), Community District 8, Borough of the Bronx (the "Application");

WHEREAS, the Application is related to ULURP Application No. C 010283 MMX (L.U. No. 399), an amendment to the City Map involving the elimination, discontinuance and closing of The Post Road north of West 246th Street;
