# THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 834

Resolution approving the site plan for a public school facility to be located on the south side of East 176<sup>th</sup> Street between Bathgate and Third Avenues (Block 2923, Lots 17, 23 and 26), Bronx

### By Council Members Katz and Lappin

WHEREAS, the New York City School Construction Authority submitted to the Council on April 12, 2007 a site plan dated April 9, 2007 pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 570-seat intermediate/high school facility, known as Eagle Academy For Young Men, Bronx, to be located at the south side of East 176<sup>th</sup> Street between Bathgate and Third Avenues (Block 2923, Lots 17, 23 and 26), in DOE Instructional Region No. 1/Community School District No. 9, Community Board No. 6, Borough of the Bronx (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on April 17, 2007;

WHEREAS, the Council has considered the relevant environmental issues and the Conditional Negative Declaration issued on March 9, 2007 (SEQR Project Number 07-011); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;
