### THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 891

Resolution approving the site plan for a new, approximately 650-seat primary/intermediate public school facility to be located generally on the block bounded by 65<sup>th</sup> Drive, Juniper Valley Road, 69<sup>th</sup> Place, and 70<sup>th</sup> Street in the Middle Village section of Queens (Block 3027/Lot 37), Queens (Non-ULURP No. 20075210 SCQ; Preconsidered L.U. No. 459).

WHEREAS, the New York City School Construction Authority submitted to the Council on May 10, 2007, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 650-seat primary/intermediate public school facility known as P.S./I.S. 128, Queens, accommodating students from pre-kindergarten through eighth grade, to be located generally on the block bounded by 65<sup>th</sup> Drive, Juniper Valley Road, 69<sup>th</sup> Place, and 70<sup>th</sup> Street in the Middle Village section of Queens (Block 3027/Lot 37), in DOE Instructional Region No. 4/Community School District No. 24, Community Board No. 5, Borough of Queens (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on May 15, 2007;

WHEREAS, the Council has considered the relevant environmental issues and the Conditional Negative Declaration issued April 3, 2007 (SEQR Project Number 07-013); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;

RESOLVED:

The Council finds that the action described herein will have no significant effect on the environment; and

Pursuant to Section 1732 of the Public Authorities Law, the Council approves the Site Plan.
