RESOLUTION APPROVING THE MODIFICATION (MN-6) OF UNITS OF APPROPRIATION AND THE TRANSFER OF CITY FUNDS BETWEEN AGENCIES PROPOSED BY THE MAYOR PURSUANT TO SECTION 107(b) OF THE CHARTER OF THE CITY OF NEW YORK.

By Council Members Weprin and Felder:

Whereas, At a meeting of the Committee on Finance of the City Council of the City of New York (the "City Council") on June 15, 2007, the Committee on Finance received a communication, dated June 15, 2007, from the Office of Management and Budget of the Mayor of The City of New York (the "Mayor"), of a proposed request, attached hereto as Exhibit A (the "Modification"), to modify units of appropriation and transfer city funds in the amount of \$971,534,817 between various agencies in the Fiscal Year 2007 expense budget as adopted by the Council on June 29, 2006, pursuant to Section 107(b) of the Charter of the City of New York (the "Charter"); and

Whereas, Pursuant to Section 107(b) of the Charter, the City Council has thirty (30) days after the first stated meeting of the City Council following such receipt within which to act upon the Modification;

NOW, THEREFORE, The Council of The City of New York hereby resolves as follows:

1. Approval of Modification. The City Council hereby approves, pursuant to Section 107(b) of
