WHEREAS, the New York City School Construction Authority submitted to the Council on June 14, 2007, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for an approximately 850-seat high school facility, known as the Beacon High School, located generally on the north side of West 61 <sup>st</sup> Street between Amsterdam and West End Avenues (Block 1154, Lot 108), in DOE Instructional Region No. 10/Community School District No. 3, Community Board No. 7, Borough of Manhattan (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on June 19, 2007;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;
