WHEREAS, the Department of Consumer Affairs filed with the Council on July 5, 2007 its approval of the petition dated July 5, 2007 of Gadberry Pizza, Inc., d/b/a Bleecker Street Pizza (the "Applicant"), for a revocable consent to continue to maintain and operate an unenclosed sidewalk café located at 69-71 Seventh Avenue South, Community District 2, Borough of Manhattan, (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(g) of the Administrative Code;

WHEREAS, upon due notice, the Council held a public hearing on the Petition on August 20, 2007; and
