WHEREAS, the Department of Consumer Affairs filed with the Council on August 3, 2007 its approval of the petition dated August 2, 2007 submitted by Tanti Baci Caffè, LLC, (the "Applicant"), for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 135 ½ Seventh Avenue South, Community District 2, Borough of Manhattan, (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
