WHEREAS, the Landmarks Preservation Commission filed with the Council on July 10, 2007, a copy of its designation dated June 26, 2007 (the "Designation"), of the Crotona Play Center (Exterior), located at Fulton Avenue between East 172<sup>nd</sup> Street and East 174<sup>th</sup> Street, Community District 3, Borough of the Bronx, as a historic landmark and Block 2941, part of Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on September 4, 2007 its report on the Designation dated September 4, 2007 (the "Report");
