WHEREAS, the Landmarks Preservation Commission filed with the Council on November 9, 2007 a copy of its designation dated October 30, 2007 (the "Designation"), of the 513 Grand Street House located at 513 Grand Street, Community District 3, Borough of Manhattan, as a landmark and Block 288, Lot 42, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 26, 2007 its report on the Designation dated December 19, 2007 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 22, 2008; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
