WHEREAS, the Department of Consumer Affairs filed with the Council on January 18, 2008 its approval dated January 17, 2008 of the petition of Eisen and Son, Inc, d/b/a Lasagna Ristorante, for a revocable consent to continue to maintain and operate an unenclosed sidewalk café located at 196 Eighth Avenue, Community District 4, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
