Whereas, bills have been introduced in the New York State Legislature by Senator Maltese, S. 6756, and Assembly Member Abbate, A. 9962, "AN ACT to amend the retirement and social security law, in relation to the establishment of a twenty-year retirement program for deputy sheriffs who are subject to article 15 of such law, and in relation to providing for employer pick up, pursuant to provisions of the internal revenue code, of certain additional member contributions required to be made by certain participants in the twenty-year retirement program"; and
